REGULATION & OPTIONAL UNIFORMS

Regulation Uniform

- Regulation uniforms are to be worn on field trips, for school pictures and special events, such as Open House and Closing Chapel.
- **Important Note:** All uniform pants for boys and girls **must** be purchased from Lands' End.

Optional Uniform Items

- Optional attire (shorts, long-sleeved polos, etc.) may be worn on regular school days.
- Students are not required to own optional pieces of the school uniform. Only the regulation uniform is required.

DRESS REQUIREMENTS FOR ALL STUDENTS

Backpacks & Lunch Bags | Backpacks and lunch bags may be any color, but may NOT have any pictures (cartoon characters, superheroes, Hello Kitty, etc.).

Belts | Belts must be worn with shorts and pants

Hair | Hair should be clean and neat. Boys' hair should be neatly trimmed. Coloring of hair and extreme styles are not permitted and students may be sent home until the matter is rectified.

Hats | Winter hats may be worn outdoors during cold weather. These hats should be solid gray, navy blue, or black with no logos or pictures.

Jewelry | Limited to small chains, pendants and watches. Girls with pierced ears may wear small studs. Hoop earrings are limited to the size of a dime. Only one earring per ear lobe may be worn.

Length of Pants and Skirts | Pants must cover socks. Jumpers, dresses, skirts and skorts must be knee-length.

Make-up | Girls in kindergarten-eighth grades may wear clear or light pink nail polish only. Fingernails should not be so long that they are a distraction or impede schoolwork. Artificial nails of any kind are not permitted. Light, modestly applied makeup may be worn only by girls in 7th grade and above.

Modesty | Girls are encouraged to wear navy blue bicycle shorts under the uniform skirts and jumpers.

Outerwear | Outerwear items (jackets, sweatshirts, etc.) may be purchased through Lands' End or any other store. NO outerwear shall be worn inside the classroom except items that bear the school logo.

P.E. Clothes | P.E. clothes are required for students in fourth-eighth grades. Please see below for requirements.

Shirts | Shirts and undershirts must be tucked in at all times.

Sunglasses | Sunglasses are not permitted at any time unless medically necessary. Written notification must be provided by the student's physician.

Uniform Upkeep | Uniforms must be clean, neat, properly fitting, and in good repair at all times.

UNIFORM POLICY – GIRLS

Girls Regulation Uniform | Kindergarten – Fourth Grade

- **JUMPER:** Girls' Uniform Plaid Jumper – Classic Navy Plaid; jumper should be KNEE LENGTH; modesty shorts should be worn underneath.
- **SHIRT:** Girls' Short Sleeve Peter Pan Knit Top – White (with GVCA logo).
- **SHOES:** Black or navy blue Mary Janes OR all-white tennis shoes (devoid of colored stripes, trim, decorations, and lights). No high tops, platforms, high heels, flats, or boots are permitted.
- **SOCKS:** White socks; must cover the ankles.

Girls Regulation Uniform | Fifth Grade – Eighth Grade

- **SKIRT:** Plaid Pleated Skirt (Below The Knee) – Classic Navy Plaid; skirt should be KNEE LENGTH.
- **SHIRT:** Short Sleeve Feminine Fit Interlock Polo Shirt – White (with GVCA logo).
- **SHOES:** Black or navy blue Mary Janes OR all-white tennis shoes (devoid of colored stripes, trim, decorations, and lights). No high tops, platforms, high heels, flats, or boots are permitted.
- **SOCKS:** White socks; must cover the ankles.

For All Girls | Kindergarten – Eighth Grade

- **HAIR ACCESSORIES**
 - Hair accessories may be purchased at any store.
 - Items should be navy, black, burgundy, white, gray, or clear in color and should not be excessively big or attention-drawing.
 - “Classic Navy plaid” or “Classic Navy” hair accessories from Lands’ End are permitted.
- **SOCKS & TIGHTS**
 - White, navy blue, or black socks, tights, or knee socks are permitted (ankles must be covered).
 - Tights are not to be worn under shorts.
 - Leggings are prohibited.

UNIFORM POLICY – BOYS

Boys Regulation Uniform | Kindergarten – Fourth Grade

- **SHIRT:** Short Sleeve Solid Performance Mesh Polo Shirt – Burgundy (with GVCA logo).
- **PANTS:** Plain Front Iron Knee Blend Chino Pants – Classic Navy.
- **BELT:** Leather or stretch belt – Navy blue or black.
- **SHOES:** All-black loafers OR all-black tennis shoes (devoid of colored stripes, trim, decorations and lights). No high tops.
- **SOCKS:** White, black, or navy blue socks; must cover the ankles.

Boys Regulation Uniform | Fifth Grade – Eighth Grade

- **SHIRT:** Short Sleeve Solid Performance Mesh Polo Shirt – White (with GVCA logo).
- **PANTS:** Plain Front Iron Knee Blend Chino Pants – Classic Navy.
- **BELT:** Leather or stretch belt – Navy blue or black.
- **SHOES:** All-black loafers OR all-black tennis shoes (devoid of colored stripes, trim, decorations and lights). No high tops.
- **SOCKS:** White, black, or navy blue socks; must cover the ankles.

P.E. UNIFORM POLICY | FOURTH GRADE-EIGHTH GRADE

Students must wear particular clothing for P.E. class. P.E. shirts must be purchased through Lands' End. A variety of athletic shorts and pants are available on our Lands' End uniform page, but students are not required to purchase these items from Lands' End.

- **SHIRT:** GVCA P.E. Shirt (purchased from Lands' End).
- **SHORTS:** Only solid navy, black, or gray athletic shorts are to be worn for PE (stripes on side are ok). Shorts should be at least finger-tip length. Uniform shorts are not permitted. Bike shorts are not permitted.
- **SWEATPANTS:** Only solid navy, black, or gray athletic pants may be worn for PE (stripes on side are ok). Leggings and other skin-tight pants are prohibited. Uniform pants are not permitted.
- **SHOES:** Supportive athletic shoes and socks are required for safety. P.E. shoes do not need to be solid black or white (colored stripes and trim are permitted). No high tops.

NOTE: P.E. clothes must be clean and in good condition (no holes, intact hem, not bleached, etc.).
